PAYMENT OF MANAGEMENT FEES BY WAY OF ISSUE OF STAPLED SECURITIES IN ASCOTT RESIDENCE TRUST

Ascott Residence Trust Management Limited (the “**Reit Manager**”), as manager of Ascott Real Estate Investment Trust (“**Ascott Reit**”), and Ascott Business Trust Management Pte Ltd (the “**BT Trustee-Manager**”), as trustee-manager of Ascott Business Trust, wish to announce that a total of 3,318,101 stapled securities in Ascott Residence Trust (“**Stapled Securities**”) have been issued by the Reit Manager and the BT Trustee-Manager as follows:

- (a) 2,904,620 Stapled Securities to the Reit Manager as partial payment of the base fee for the period from 1 January 2022 to 31 March 2022 (both dates inclusive) at an issue price of S\$1.0968 per Stapled Security.

The aforesaid base fee are computed in accordance with the provisions stipulated in the Ascott Reit deed of trust dated 19 January 2006 (as amended); and

- (b) 413,481 Stapled Securities to the BT Trustee-Manager as partial payment of the base fee and performance fee for the period from 1 January 2022 to 31 March 2022 (both dates inclusive) at an issue price of S\$1.0968 per Stapled Security.

The aforesaid base fee and performance fee are computed in accordance with the provisions stipulated in the Ascott BT deed of trust dated 9 September 2019 (as amended).

With the above-mentioned issue of Stapled Securities, the total number of Stapled Securities in issue is 3,286,849,638, the Reit Manager holds an aggregate of 233,314,648 Stapled Securities (7.098%) and the BT Trustee-Manager holds an aggregate of 4,605,325 Stapled Securities (0.140%) respectively.
