PAYMENT OF ACQUISITION FEES BY WAY OF ISSUE OF STAPLED SECURITIES IN CAPITALAND ASCOTT TRUST

CapitaLand Ascott Trust Management Limited (the "**REIT Manager**"), as manager of CapitaLand Ascott Real Estate Investment Trust (the "**REIT**"), and CapitaLand Ascott Business Trust Management Pte. Ltd. (the "**BT Trustee-Manager**"), as trustee-manager of CapitaLand Ascott Business Trust (the "**BT**"), wish to announce that a total of 3,151,715 stapled securities in Capitaland Ascott Trust ("**Stapled Securities**") have been issued to the REIT Manager at an issue price of S\$0.9463 per Stapled Security.

The 3,151,715 Stapled Securities were issued as payment of the Acquisition Fees (as defined in the REIT Trust Deed) in relation to the acquisition of serviced residence properties in France, Vietnam and Australia, rental housing properties in Japan and a student accommodation property in South Carolina, US (the "Acquisitions").

Under the Trust Deed, the REIT Manager is entitled to receive such number of Stapled Securities as may be purchased for the relevant amounts of the Acquisition Fee, being 1.0 percent of the Enterprise Value (as defined in the REIT Trust Deed) of the Acquisitions.

The manner of payment of the Acquisition Fee is disclosed in (i) the REIT Trust Deed, (ii) the REIT Prospectus dated 6 March 2006; and (iii) Circular to Stapled Securityholders of CapitaLand Ascott Trust dated 15 August 2022 on inter alia, the Acquisitions.

With the above-mentioned issue of Stapled Securities, the total number of Stapled Securities in issue is 3,459,273,565, the REIT Manager holds an aggregate of 251,398,876 Stapled Securities (7.267%).
