CLAS is a stapled group comprising CapitalLand Ascott Real Estate Investment Trust ("CapitalLand Ascott REIT") and CapitalLand Ascott Business Trust ("CapitalLand Ascott BT"). Each stapled security of CLAS comprises one unit in CapitalLand Ascott REIT and one unit in CapitalLand Ascott BT. The manager of CapitalLand Ascott REIT is CapitalLand Ascott Trust Management Limited and the trustee-manager of CapitalLand Ascott BT is CapitalLand Ascott Business Trust Management Pte. Ltd..

As each stapled security in CLAS comprises one unit in CapitalLand Ascott REIT and one unit in CapitalLand Ascott BT, this notification is for the stapled securities in relation to Part I paragraph 1. Any reference to units above relates to the stapled securities in CLAS.
