	In relation to item 7 of Transaction A and Transaction B, CLASBTMPL is entitled to receive 785,944 stapled securities in CLAS at an issue price of \$\$0.8686 per stapled security as partial payment of the base fee and base performance fee for the period from 1 April 2025 to 30 June 2025 (both dates inclusive). CLASBTMPL has sold the 785,944 stapled securities which it is entitled to receive, to Somerset Capital Pte Ltd ("SCPL"), a related corporation of CLASBTMPL, and in connection with the sale, CLASBTMPL has directed that such stapled securities be issued directly to SCPL instead of CLASBTMPL.
